Introduction

Newlands School is committed to creating a safe, supportive, and drug-free environment. This policy is aligned with the UAE National Program for Drug Prevention (SIRAJ), the Drugs Prevention at School Environment Guide (2021), and Federal Law No. 14 of 1995 on combating narcotics and psychotropic substances

Policy Objectives

- 1. Prevent the use of narcotics and psychotropic substances within the school.
- 2. Reduce the demand for drugs by raising awareness and instilling positive values.
- 3. Equip students with life skills to resist peer pressure and make healthy choices.
- 4. Provide early detection and timely intervention for at-risk students.
- 5. Reinforce the roles of staff, parents, and community partners in prevention.
- 6. Ensure reintegration and rehabilitation support for affected students.

Roles and Responsibilities

Principal

- Ensure implementation of drug prevention policies.
- Coordinate with health, security, and social authorities.
- Oversee awareness campaigns and staff training.
- Monitor policy enforcement and compliance.

Teachers

- Act as positive role models.
- Integrate awareness into lessons (Science, Social Studies, PSHE).
- Observe and report behavioral/physical indicators of drug use.
- Promote life skills such as decision-making and peer-pressure resistance.

School Councilor

- Provide counseling and early intervention for at-risk students.
- Run awareness sessions for parents and students.
- Develop individual support/reintegration plans in partnership with treatment centers

Students

- Adhere to school rules and code of conduct.
- Report peer pressure, bullying, or suspected cases of narcotics.
- Engage in healthy extracurricular, sports, and volunteer activities.

Parents

- Build strong, trust-based relationships with children.
- Attend school workshops on drug awareness.
- Monitor friendships, online safety, and leisure activities.
- Collaborate with the school in supporting intervention and rehabilitation.

Preventive Measures & Action Steps

A. Awareness and Education

- Annual awareness campaigns on health, social, and legal impacts of drugs.
- Integration of drug prevention messages into curriculum subjects.
- Themed assemblies and participation in International Anti-Drug Day. (Day/date)

B. Capacity Building

- Annual training for teachers, counselors, and administrators on early detection.
- Dissemination of official government materials (Siraj program resources).

C. Life Skills Development

- Structured sessions on decision-making, problem-solving, refusal skills, and coping with stress.
- Encouragement of sports, arts, volunteering, and cultural activities.

D. Early Detection & Intervention

- Monitoring systems for attendance, behavior, and performance.
- Confidential referral pathways to counselors/school leaders/ child-protection team
- Clear reintegration plans for recovering students, avoiding exclusion.

E. Policy & Enforcement

- Zero-tolerance for possession, promotion, or distribution of narcotics on school grounds.
- Alignment with Federal Law No. 14 of 1995: strict penalties, but provision for treatment and rehabilitation.
- Clear Code of Conduct communicated to students and parents annually.

Partnerships

Collaboration with Dubai Police – Anti-Narcotics Department, healthcare authorities, and rehabilitation centers (e.g., Erada, Al Amal Hospital).

Joint awareness campaigns and referral systems.

Monitoring & Evaluation

Strategic Indicators

- Increased percentage of students reporting increased awareness of drug risks.
- Reduction in new cases of substance use at school.
- Number of preventive programs delivered annually.

- Number of trained staff.
- Number of students engaged in awareness/life skills programs.

3. Adolescence (11–16 years / Secondary Y7–Y13, including IGCSE/AS/AL)

Focus	High-risk stage; strong emphasis on refusal skills and resisting peer pressure.		
Content	Detailed awareness of narcotics, misconceptions, UAE laws, peer influence, online safety, decision-making.		
Approach	Structured sessions (≥10 hours per year), workshops, debates, simulation activities

UAE Legal Framework

The National Program for Drug Prevention (SIRAJ) mandates that all public and private schools and universities deliver preventive education.

Federal Law No. 14 of 1995 criminalizes abuse and promotion of narcotics, but provides protection and rehabilitation routes for minors and students who voluntarily seek help.

The Guide explicitly instructs schools to embed preventive education across all phases — early childhood through adolescence — not just in secondary years.
